Circus Vidbel Agrees To Provide:

- * ____ (#) complete circus performances, tent, seats, and personnel
- *Public liability and property damage insurance of \$1 million (single incident)/\$2 million (aggregate) covering the Sponsor, property owner and municipality
- *Advance Show Tickets, advertising posters and promotional materials
- *Generator for electricity
- *Cleanup of circus grounds

The Sponsor Agrees To Provide:

- *Show Grounds of 200ft.X 200ft.(approx.) that is level, mowed, in usable condition with access for large vehicles
- *Adequate parking for circus patrons.
- *Permission for Circus Vidbel to obtain water suitable for drinking from a nearby hydrant or faucet within 500 ft. of the tent.
- *Any necessary permits or licenses, fire or police services if required by local or state law
- *Dumpster or truck to be used by circus for cleanup of the showground
- *Portable restroom facilities if none is available within 500 ft. of the showground
- *Any other amenities as required by local or state law.

Ticket Prices*: Advance - \$8.00 Circus Day - \$10.00

*(Children 2 yrs. and under are free)

Advance Sale of Tickets by Sponsor

The sponsor receives 40% of all advance sales made prior to circus day on sales over \$2,500.00.
The sponsor receives 30% of all advance sales made prior to circus day on sales under \$2,500.00.

Circus Day Ticket Sales at Circus Ticket Office

Sponsor receives 10% of circus day ticket sales if their advance sale is between \$2,500.00 and \$3,500.00 dollars.
Sponsor receives 20% of gate sales if their advance sale is more than \$3,500.00 dollars.

Other Agreements and Conditions:

- *The Sponsor does not participate in the proceeds from the concession sales and agrees not to sell or permit the sale of concessions of any nature on the circus grounds during the Circus Vidbel appearance.
- *If the Sponsor is subject to taxes on the sales of tickets, they will be responsible for remitting said taxes to the appropriate municipality and/or state agency.

***Circus Vidbel will have control** over the arranging and erecting of the entrances and tents, placement of the circus equipment and the start and presentation of the circus performances. To assure the safety of the general public and circus performers, all persons (excluding fire, police, medical and state officials) will be restricted from areas where trucks, house trailers animals and other circus paraphernalia and performers entrances to the tent are located.

***Circus Vidbel reserves the right to distribute advertising, posters,** promotional materials and promotional tickets in advance of the show.

Circus Vidbel will not be held liable for nonperformance due to Acts of God and other circumstances beyond the control of circus management.

-The Sponsor agrees that no tickets will be sold by them on circus day or they forfeit their share of tickets sold at the circus ticket office on circus day.

-The Sponsor agrees to make final settlement with Circus Vidbel, in cash, on all advance tickets sold and to return all unsold tickets at 10:30am on circus day at the Circus Vidbel Ticket Office.
